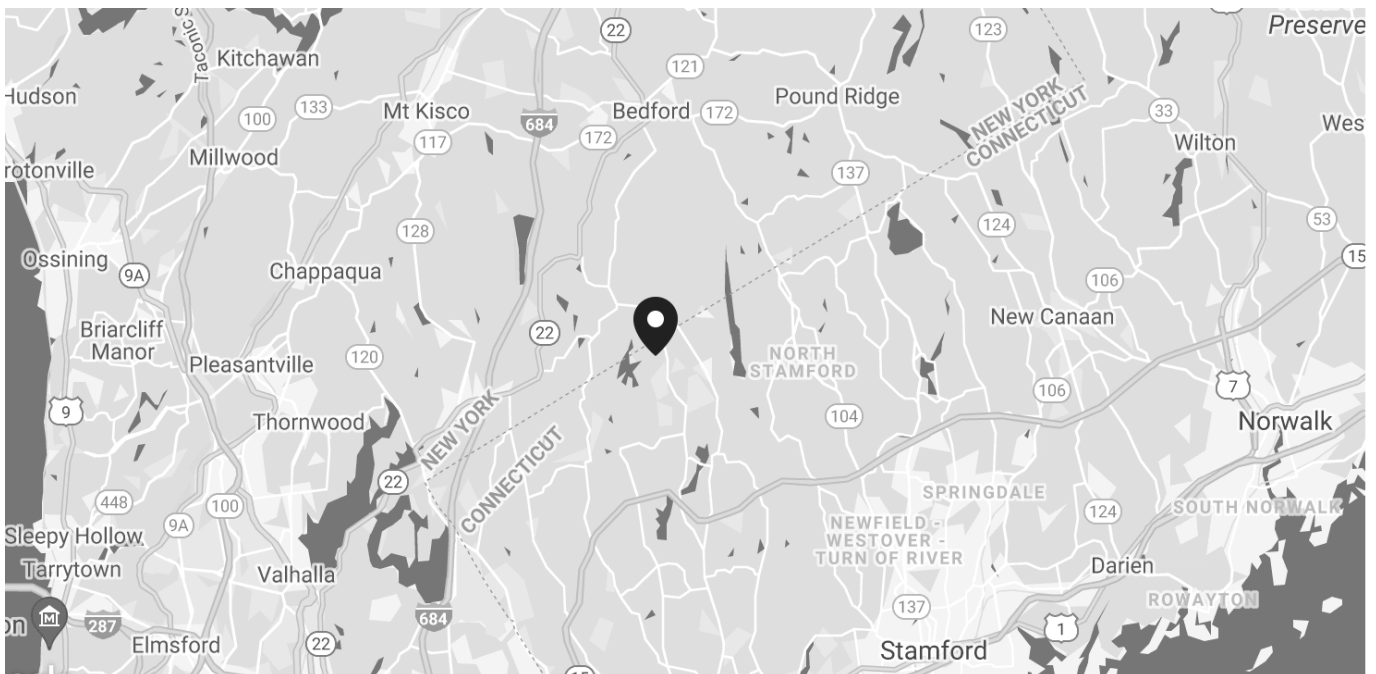

CSI GREENWICH 2*/5* RULES & REGULATIONS

Refer to the FEI Definite Schedule regarding invitation to compete, FEI entry information, stabling, competition start orders, prize money breakdown and payment and competition fees.

ENTRIES

Entries are limited to 50 riders/2 horses per rider per division. Entries must be submitted electronically via Horse Show Management System (showmanagementsystem.com).

A non-refundable deposit of \$100 USD is required with each entry; balance of entry fee will be due upon acceptance. Any entry scratched after the closing date will forfeit their deposit. Competitors are encouraged to submit entries as soon as possible. Entries received after the two divisions have filled will be placed on a waitlist in order of received entries. Under extreme circumstances, management reserves the right to accept or deny any entry.

An accepted entry that scratches after the close of Definite Entries will be charged \$500.

A separate entry must be competed for each horse. Each entry must be signed by the owner, rider, trainer, and coach (if applicable) and said signature shall constitute verification that the information contained therein is accurate to the best of the signer's knowledge and belief.

PRIZE MONEY

Prize money will be paid in accordance with FEI rules and will be mailed within thirty (30) days of the conclusion of the show to the owner listed on the entry form, or the Payee if given and only if the owner's or payee's W-9 Form is on file with the show office. Foreign competitors must include a U.S. Tax ID Number on their entry form or will be asked to complete a W-8BEN or W-8 Certificate of Foreign Status Form.

FEI ONLINE ENTRY

Entries are required to be filed with the FEI Online Entry System by the Athlete's Federation. In addition, athletes are required to complete the show's entry form and submit them to the show secretary (see above). Entries will be accepted by the Organizer; schedule of fees due with entry as noted on in the FEI Definite Schedule.

Post entries and substitutions accepted only with Organizer's permission.

DRAWS

All draws are to be random or as noted by FEI & MLSJ Rules in show office except for the MLSJ team event, and Grand Prix.

Starting Order Team Competition (202) – Random draw will be conducted during a draw party at each event to determine order of go for the teams. Once the order is set, all three athletes will ride consecutively to create a team total score before the next athlete competes. Team managers must submit the order of go for their individual team to the office by noon the day before the team competition. Teams will have their riders ride consecutively in all rounds. Individual riders will be ordered before MLSJ team athletes by random draw.

Starting Order 5* Grand Prix (305) Athletes will earn points in the Class #303 and Team Competition during the MLSJ event. Points earned are as per the table in approved FEI Schedule.

BREAKING TIES

Other than for first place, athletes tied based on faults and time to 100th second will remain tied and the prize money split accordingly.

CLOSING DATES

Definite entries by September 15.

ARRIVALS/DEPARTURES

All horses and equipment must be off the showgrounds Sunday by 9:00pm.

STABLING

Stalls are temporary (10 x 10) with vinyl walls under a tent with grass flooring. Due to the limited nature of the venue, entries and stalls are limited; first bedding provided.

ARENA FOOTING & DIMENSIONS

Grass competition ring: 300' x 500'
Grass practice ring: 250' x 250'

PRIZE CEREMONY

The top six riders and horses are required to be present and participate in all prize ceremonies.

SCHOOLING

All schooling shall be held under the inspection of the Steward/Schooling Supervisor in the designated schooling area. Designated schooling areas and schooling hours will be posted in the FEI Stable Area.

VIP AND SPECTATOR TICKETS

VIP seating and a variety of spectator ticketing options are available and must be purchased in advance. Visit csigreenwichllc.thundertix.com for more information and to purchase.

MOTORIZED VEHICLES

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized

vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Due to the nature of the venue, no motorized vehicles other than wheelchairs and other mobility assistance devices for individuals with disabilities are allowed outside of the car parking area.

LEASH LAW

Dogs must be on a leash and under control at all times. Dog owners who fail to comply with the USEF rules regarding dogs may be subject to penalty, including \$100 fine per incident, and/or warning cards issued. Dog owners are solely responsible for any damages, claims, losses, or actions resulting from their dog's behavior.

ATTIRE

As required by FEI and USEF rules. For additional USEF rules see GR801 regarding safety helmets and other equipment.

FARRIER

No farrier other than the official competition farrier will be permitted to shoe on the grounds without the express permission of the Management.

MEDICAL WASTE

In accordance with the 1989 Federal Waste Tracking Act which restricts the disposal of medical waste, Bio Hazardous Medical Waste Containers will be provided in the stable area. All Exhibitors and their agents are responsible for the proper disposal of this waste.

LIABILITY AND INSURANCE

CSI Greenwich LLC, Greenwich Polo Club Inc., the Town of Greenwich, New York, their officials, sponsors and employees will not be responsible for any accident or loss which may occur to any exhibitor, spectators, guest, rider, groom, attendant or other employee, animal or equipment at any of the competition.

All owners and competitors are personally responsible for damages to third persons caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.

Should any question arise that is not provided for in the rules, the same shall be referred to the competition committee whose decision shall be final. In exceptional circumstances, together with the approval of the Ground Jury the OC reserves the right to modify the schedule in order to clarify any matters or matters arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all competitors and officials as soon as possible and they must be reported to the Secretary General by the Foreign Judge.

FEI AND USEF RULES AND INFORMATION

FEI MEMBERSHIP FOR HORSES & RIDERS

As approved at the 2006 General Assembly, an annual FEI registration is now mandatory for all riders and horses competing in FEI events. The fee requirement took effect January 1, 2006 and must be renewed annually. All horses and riders must be registered with the FEI before competing in any 2021 FEI competition.

FEI HORSE PASSPORTS

Every horse entered for any competition at CSNs or CSI*/** in a foreign country, all horses entered for other CSI**/***/****/***** , CSIOs, Championships, Regional, and Olympic Games whether at home or in foreign countries must have an official, valid, FEI passport, or a National passport approved by the FEI accompanied by a FEI Recognition Card, as a means of identification and to establish ownership.

EQUINE INFLUENZA PROTOCOL

All horses participating in FEI events must be vaccinated against Equine Influenza, according to the following minimum protocol (FEI Veterinary Regulations Article 1028):

1. An initial primary course of two vaccinations must be given, the second vaccination must be administered within 21-92 days of the first vaccination.
2. The first booster must be given within 7 calendar months following the date of administration of the second vaccination of the primary course. All horses that were certified as correctly receiving the primary course prior to January 1, 2005 (under previous regulations), are not required to fulfill the requirement for the first booster, providing there has been no lapse in their vaccination regime.
3. The minimum booster frequency is every 12 months. However, for horses competing, the last booster must have been given within 6 months plus 21 days (and not within 7 days) before the arrival at the Event.
4. The horse must have received at least the primary course of vaccinations against Equine Influenza.
5. No vaccination shall be given within 7 days of the horse's arrival at the Event.

THE FEI CODE OF CONDUCT

The FEI requires all those involved in international equestrian sport to adhere to the FEI Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount. Welfare of the horse must never be subordinated to

competitive or commercial influences. A full copy of the FEI Code of Conduct can be obtained from the Federation Equestre Internationale at HM King Hussein 1 Building, Chemin de la Joliette 8, 1006 Lausanne, Switzerland. FEI RULES & REGULATIONS

CSI Greenwich 2*/5* will be conducted in accordance with FEI Statutes (23rd Edition, effective November 7, 2013); FEI General Regulations (23rd Edition, effective January 1, 2014); FEI Veterinary Regulations (13th Edition, effective January 1, 2014); FEI Rules for Jumping Events and its Annexes (24th Edition, effective January 1, 2014); FEI Anti-Doping Rules for Human Athletes (3rd Edition, effective January 1, 2014); and all subsequent revisions to the above Rules and Regulations which will take precedence. An arbitration procedure is provided for the FEI statutes and General Regulations as referred above. In accordance with this procedure, any appeal against a decision rendered by the FEI or its official bodies must be settled exclusively by the Court of Arbitration for Sport (CAS) in Lausanne, Switzerland.

USEF RULES

The classes herein which are covered by the rules and specification of the current USEF Rule Book and current FEI rules and regulations.

LIFE, SENIOR ACTIVE AND JUNIOR ACTIVE MEMBERS SHALL BE ELIGIBLE TO PARTICIPATE IN ALL CLASSES AT REGULAR COMPETITIONS, EVENTING COMPETITIONS AT THE PRELIMINARY LEVEL OR ABOVE AND COMBINED DRIVING COMPETITIONS AT THE ADVANCED LEVEL, DRESSAGE, REINING AND VAULTING COMPETITIONS AND ENDURANCE RIDES. A NON-MEMBER MAY PARTICIPATE AS A HANDLER, RIDER, DRIVER, OWNER, LESSEE, AGENT, COACH OR TRAINER AT REGULAR COMPETITIONS, EVENTING COMPETITIONS, DRESSAGE COMPETITIONS, REINING COMPETITIONS AND COMBINED DRIVING COMPETITIONS UPON PAYMENT OF A \$45 SHOW PASS FEE. PARTICIPANTS IN THE FOLLOWING CLASSES ARE EXEMPTED FROM THE REQUIREMENTS OF THIS RULE: 1) LEADLINE; 2) EXHIBITIONS; 3) GAMES AND RACES; 4) CLASSES FOR 4-H MEMBERS; 5) WALK TROT (EXCEPTION: FRIESIAN PERFORMANCE FR218) AND ACADEMY CLASSES (ACADEMY CLASSES ARE CLASSES LIMITED TO HORSES USED REGULARLY IN A LESSON PROGRAM); 6) USDF INTRODUCTORY LEVEL TESTS, PAS DE DEUX AND QUADRILLE CLASSES; 7) NRHA

ENDORSED REINING COMPETITIONS. 8) OPPORTUNITY CLASSES, 9) CITIZENS OF OTHER NATIONS WHO HAVE PROOF, IN ENGLISH, OF CURRENT MEMBERSHIP IN GOOD STANDING OF THEIR OWN NATIONAL FEDERATION, 10) USEA BEGINNER NOVICE DIVISION; AND 11) ASSISTANT HANDLERS IN DRESSAGE SPORT HORSE BREEDING CLASSES.

USEF ENTRY AGREEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR222) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

EQ103: ELIGIBILITY TO COMPETE

Presentation of USEF Federation Membership Cards: All owners, senior, junior, amateur, adult amateur riders and trainers are required to present the actual or a copy of their Federation membership card to the Show secretary. Failure to present card will result in a \$45 per USEF and \$30 per USHJA fee (\$75 total) charged by USEF show pass fees. Junior and pony hunters must present the actual or a copy of their measurement cards at the Show Office before numbers may be picked up. All ponies and junior hunters that do not possess a current measurement card will be measured. All non-members will be charged a show pass fee by USEF. Time and place of measurement stations will be announced.

1. In order to compete in any Hunter/Jumping Seat Equitation classes at licensed competitions as an exhibitor, rider, trainer, or his/her agent(s), a person must be an Active member of the United States Hunter Jumper Association, Inc., or pay a Show Pass fee to the United States Hunter Jumper Association, Inc. Exception: Local Competitions and exceptions listed in GR901.9.

Exception: Breed restricted Hunter/Jumping Seat Equitation classes.

2. USHJA Horse Registrations. a. All horses competing in Federation licensed and/or USHJA sanctioned competitions with Hunter, Hunter Breeding, Jumper and Hunter/Jumping Seat Equitation classes not restricted by breed must be properly identified in accordance with GR1101, and must also be registered with USHJA (See GR1101.1). The USEF/USHJA registration number for each horse must be entered on all entry forms for licensed competitions. b. Applications for USHJA Registration can be completed online at ushja.org or usef.org using the USEF Horse Registration application form. This form is also available from the USHJA or Federation office, as a download from the USHJA or Federation website or from competition management. Competition management is responsible for notifying exhibitors of this requirement in their prize list.

3.1 In addition to the provisions of EQ103.2, on or after December 1, 2017, all horses competing in classes that require USHJA horse registration must provide a microchip number that verifies their animal's identity in order to compete for points, money won or be eligible for Federation and/or USHJA programs and awards where horses are required to be recorded or registered.

3.2 A microchip used to verify identity must be a fifteen digit ISO compliant 11784/11785 chip and be implanted in the nuchal ligament of the animal. FEI horses will follow FEI Rules.

SAFE SPORT REMINDER

Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and CSI Greenwich LLC ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors,, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

EQUINE ACTIVITY LIABILITY ACT WARNING:

CAUTION: HORSEBACK RIDING AND EQUINE ACTIVITIES CAN BE DANGEROUS. RIDE AT YOUR OWN RISK.

Under the laws of most States, an equine activity sponsor or equine professional is not liable for any injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities.

C. ASSUMPTION OF RISK: I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the USEF Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any USEF Events. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.

D. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (**Individually and Collectively, the "Released Parties" or "Event Organizers"**), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("**Liability**") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

E. COMPLETE AGREEMENT AND SEVERABILITY CLAUSE: This Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.
